



# D11NR Statistics\*





Stats from AUXINFO\* indicate that we are 9% of our 2014 goal and 166% of 2013 production. Additional stats from AUXINFO\* indicate that 95% or 951 have passed the VSC, 35% or 396 are First Time VSC's, 27% or 302 are High Risk VSC's. In addition, 31% or 357 are paddlecraft VSC's. VSC Questions: These are actual test questions from the 2007 VE Exam Version "F" Answers can be found in another location in the newsletter

1- Operational Facilities 12 meters (39.4 feet) or more in length must own and Maintain:

- a. A Quick Reference Navigation Rules card.
- b. Navigation Rules publications, COMDTINST M16672.2
- c. Quick Reference & Navigation Rules publications COMDTINST M16672.2
- d. Coxswains are not required to own Navigation Rules Publications

2-Inflatable Life Jackets (PFDs) are becoming more and more popular. You are examining a 22' stern drive vessel with two adults and two pre-teen children aboard. They proudly show you their four new inflatable PFDs, out of the manufacturer's original packaging. If everything else is okay, can you issue a VSC decal?

- a. No. Inflatable Life Jackets (PFDs) are not yet Coast Guard Approved so they don't count as acceptable for carriage
- b. No, inflatable Life Jackets (PFDs) are not approved for children under 16 years of age. The VE should remind the boat owners to remove Life Jackets (PFD's) from the manufacturer's packaging.
- c. Yes, but be sure to recommend that they remove them from the packaging since Life Jackets (PFDs) in plastic are not readily accessible.
- d. Yes, but you need to remove them from the packaging, examine the firing device by removing the CO2 cartridge to determine it has not been used.

-YOUR D11NR Vessel Examiner (VE) website recently passed over the **25,000** hit mark and is being utilized as a one stop resource for which it was designed in 2009 by Irene Wetzel DSO-CS and me. This is still the ONLY site of its kind in the Auxiliary, however many portions of it are being used by other Districts. Thank you to Irene for helping me bring this important asset to fruition and especially to Jan Jewel ADSO-VE/CS for maintaining it at least a weekly and sometimes daily basis for the past several years! Jan is a huge asset to the D11NR VSC program and works very hard to keep both the VE and public website fresh and current! -VSC's ON RENTALS-At the request of Commodore Collins, to maintain uniformity in the program, moving forward, ALL VSC's for rental agencies that rent pwc's, fishing boats, house boats, paddle craft, etc., will now require a D11NR Rental Agreement with the dealer. This program is relatively simple, straight forward, and is self-explanatory. You can find a copy of the agreement (ML-3) along with a sample introduction letter (if necessary) (ML-2), and basic instructions (ML-1) on the D11NR Vessel Examiner website: <u>http://rbsafety.d11nuscgaux.info/ve/ve.html</u> under "VE FORMS". Please note that to participate in this program, a Program Visitor is required. However, if you are a Vessel Examiner and a current Program Visitor, you can fulfill that requirement. Please print (2) copies-one for you to keep after signed by the vendor, and one for the vendor after you and/or the Program Visitor have signed it. You should maintain the vendor signed copy for the calendar year.

"Are you required to carry flares on your facility? The short answer is "Maybe". In order for your vessel to be approved as a facility, you must have the required number of Visual Distress Signals (VDS) onboard based on your vessel's size and where you operate it. 33CFR175.110 addresses the VDS requirements for recreational vessels (which AUXFAC's legally fall under for the purposes of Boating Safety Regulations). The federal regulation allows for different combinations of VDS to be carried onboard a vessel operating on waters where the USCG has jurisdiction. One of the accepted combinations is a Day Non-pyrotechnic VDS, such as the Orange emergency flag and one Night Non-Pyrotechnic VDS, such as the emergency strobe I issue to you in your SAR vest. Here's it gets tricky: The emergency strobe light is only acceptable as a Night non-pyrotechnic VDS shoreward of the COLREGS demarcation line. This means that if you patrol in inland waters only, as defined by the COLREGS, you are night required to have pyrotechnics onboard. A visual distress flag and your SAR Vest strobe will satisfy the requirements. Now, if you patrol beyond the COLREGS demarcation line in the offshore approaches, the only Night Non-pyrotechnic VDS accepted is an electronic "SOS" light, which is only made by a handful of manufacturers. In this case, I would recommend you purchase Day/Night combination pyrotechnics to meet the requirements. Those of you that patrol inland lakes exclusively will need to refer to the state requirements for VDS."
