VDSO Comments

Now that spring has past and the VSC season is in full swing, I'd like to take a minute to remind everyone about the mission

of the Coast Guard's Recreational Boating Safety program and some basic etiquette that we tend to forget about while at the ramp. From our VSC Manual, "The mission of the Coast Guard's Recreational Boating Safety program is to minimize the loss of life, personal injury, property damage and environmental impact associated with the use of recreational boats. The Vessel Safety Check program helps support this mission with voluntary examinations (NOT INSPECTIONS) to assure compliance of both federal and state safety laws regarding the carriage of safety equipment." As a result of our unique relationship with the Coast Guard, in many instances the public perceives us as the Coast Guard and as boating safety experts. As a result, we have responsibility to share our knowledge with the boater about the benefits of having the correct safety

equipment and boating safety in general. So, be professional, informed, prepared, courteous, and properly dressed in the the uniform of the day. That brings me to the issue of examiner etiquette. Many times while at the ramp, we forget that our voices carry, we lean on a vehicle or a boat, smoke, use profanity, etc. Sometimes we are not aware that we have a bad habit unless someone tells us. So as a result, you can find a copy of "Examiner Etiquette" here in the Newsletter, but better yet, take a minute to go to the District Vessel Examiner website http://rbsafety.d11nuscgaux.info/ve/ve.html and print out "Examiner Etiquette" under "D11NR Vessel Examiner Information" and place a copy in your clipboard as a reminder. WADSO Comments

Fellow examiners, I'd like to take a minute of discuss the correct placement of the VSC decal on a vessel.

Once all items in the left hand side of form ANSC 7012 have been verified, and after the successful completion of the vessel safety check, a decal shall be awarded. The Vessel Examiner shall immediately affix the decal or have the vessel owner affix in your presence, as the decal is not transferable. Many times, boaters who are awarded the decal insist they will place it later on e.g. after the boat has been cleaned. This is unacceptable. To eliminate this situation, it's a good idea to carry a damp rag to clean the location and a window scrapper to remove any previous decals. It's important that the decal be affixed in a location that will not interfere with or obscure the operator or passengers view and be readily visible to authorities while underway. This is generally in the lower forward corner of a portside window or a lower corner on the portside of the windshield. If no window is available or the operator has an objection, it may be affixed to the dashboard or the back of the seat. It should however be only

affixed to permanently installed equipment. At times, boat operators may prefer the decal be placed along the registration numbers in the forward side of the hull. If so desired, the decal should be placed at least three-six inches away from the state registration decal sticker that follows the registration numbers, although this is not a preferred location.

The VSC decal is only valid until December 31st of the year in which it is awarded. The Vessel Examiner shall ensure that only one decal is displayed at one time. Believe it or not, the size of the decal various a bit from year to year, so old decals should be removed before affixing the new one.

A strict accounting of decals should be required by each FSO-VE or Flotilla Commander so that there is not a local shortage as in years past. One final comment about the decal placement, PLEASE do NOT place the decal on any plastic windows on either an older vessel or a bass boat! The removal of the decal can sometimes be very messy and if you try to remove the decal with a razor blade, you risk scratching the plastic. If you are lucky enough to remove the old decal, you have the potential to leave a gooey mess with little or no hope of removing it! This leaves the boat owner with a poor impression of the VSC program and the previous examiner.

Examiner Etiquette

- 1-Wear the proper uniform and wear it CORRECTLY. If with other examiners, try to wear the same uniform.
- 2-Don't ask if the boater would like a vessel safety check-they'll probably say NO!!! Explain the VSC and politely direct them to the examination area.
- 3-When greeting the boater, do NOT lean on their truck.

4-Do NOT use the word INSPECTION! The VSC is an examination-not an inspection!

- 5-When discussing safety, make eye contact with BOTH the driver and the passenger especially when children are present.
- 6-Do not stand on the boat trailer to look in vessel unless you ask.
- 7-Do not put your clipboard or lean on the boat.
- 8-Answer questions truthfully and be prepared to substantiate the answer. Do NOT guess! It is better to not know than to guess. Know your local state boating regulations and Federal Requirements booklets.
- 9-Limit the examination to 10-15 minutes for trailer boaters-20 to 30 minutes for large vessels.
- 10-On large vessels ask permission PRIOR to boarding-ASK and be prepared to remove your shoes!
- 11-Do NOT SMOKE at the VSC station or around boaters while in uniform!
- 12- Do not discuss any prior VSC activity with other examiners when other boaters are in the area. You voice travels and you never know who may over hear your comments. Do **NOT** use profanity!
- 13-While not required by law, remove life jackets from plastic bags and YOU dispose of the bags.
- 14-If you promise a return call, be sure to follow up.
- 15-Always find something to compliment the boater.
- 16-Pass or fail, shake the owners hand, congratulate and thank him on a job well done.
- If the boater fails, offer a recheck and thank him for their time.
- 17-Above all else-BE POLITE! MAY I, PLEASE, and THANK YOU go a long way.

 - d. 16' and longer



- d. Are not necessary on Operational Facilities.


PAC AREA 2010 Statistics*
