I'd like to remind everyone that a week prior to National Safe Boating Week (NSBW), the WEAR IT

**CALIFORNIA!** campaign for the Delta area kicks-off this month on Saturday May  $15^{th}$  at Discovery Park in Sacramento. NSBW kicks-off on Saturday May  $22^{nd}$  thru  $28^{th}$  followed by VSC Mega-Weeks continues through the month of June culminating on July  $5^{th}$ . In addition, let's not forget that National Marina Day has been changed to Saturday June  $12^{th}$ .

I'm told the WEAR IT CALIFORNIA! campaign will focus more on PA events at Delta area marina's rather than on the water activities. This helps create a great opportunity for a unified message. A schedule of WEAR IT CALIFORNIA events is further in the newsletter. NSBW is an opportunity to use the ICS training we've received over recent years to plan VSC/PA activities or the concepts we learned at the RBS workshop a D/Train. This is also an opportunity to involve the FSO staff and ALL flotilla members at VSC stations that were planned and scheduled at the April Flotilla meeting by the FSO-VE. Hopefully, the FSO-MA ordered materials and the FSO-PA has SEVERAL PA announcements planned.

In addition to the PA table, CURRENT handout materials, VSC decals, and forms need to be distributed as soon as possible to the examiners so they may familiarize themselves with changes in the materials and laws. This is also an opportunity to review our etiquette and VSC greeting for VSC and PA activities as we gear-up for the summer VSC activities. More can be found on your D11NR VE website:

http://rbsafety.dllnuscgaux.info/ve.html During VSC Mega-weeks, weekly or bimonthly VSC ramp stations should be scheduled in the areas where there is the highest concentration of our target audience; trailer boats, PWC's, canoes, and kayaks. Boating accidents and death statistics have shown that trailer boaters and vessels less than 26' in general are involved in the majority of accidents. But, that is not to say that we still shouldn't provide the service to larger vessels at yacht club safety days.

Boaters don't need to be lectured or supplied a huge volume of material or unnecessarily detained from launching. Most contacts should not require more than 10 minutes at the ramp. Please staff each event accordingly. When at a ramp, each participating examiner should be able to produce about 8-10 VSC's, 4 or 5 at a yacht club safety day. That way it's worth everyone's time to participate. ALL participants need to wear the same uniform, which should have been specified in the early planning meetings. Please review Tony Budlong ADSO-VE uniform comments from last month and Chapter 10 of the Auxiliary Manual. In addition, we should also be wearing our WEAR IT! pfd's.

Fellow examiners, as we approach the start of another boating season, I'd like to take a minute of discuss the **Recommended** 

and Discussion Items on the right side of the VSC form 7012. At the completion of the Vessel Safety Check, and after covering the required items, the vessel examiner should take a few minutes to highlight the following items: make certain that that all examiners have an opportunity to participate at all outings throughout the year. If you are short on personnel, consider partnering with another flotilla, division or possibly the local Power Squadron. Finally, consider scheduling a pot-luck BBQ and possibly consider inviting the local sheriff or Power Squadron. As with all jobs, the job is not complete until the paperwork is finished! In addition to turning in your 7038's through the IS system ASAP, please don't forget to turn in your VSC stats for NSBW to your Flotilla or Dvision NSBW chairperson so you receive credit for your hard work! Finally, thanks to Phil Grove FC 10-5 for inviting me for a visit to observe VSC's at Millerton Lake on Saturday April 17<sup>th</sup>. In addition to some good fellowship on Friday evening, I observed some very professional activity at a beautiful lake on Saturday.

As always, your comments are welcome.

-Accident reporting - if loss of life, person missing or requiring medical treatment beyond first aid report to state and local authorities within 48 hours. If damage to boat over \$2000 report within 10 days.

-Offshore operations - carry additional equipment beyond federal requirements e.g. type I pfd's, Emergency Position Indicating Radio Beacon, inflatable life raft. -Nautical charts - carry properly updated charts having the largest possible scale.

-Survival tips and First Aid Kit -Highly recommend boaters take a first aid course and carry spare medications in their first aid kit, and suggest a CPR class to assist in medical emergencies. Be prepared for hypothermia. -Fueling and Fuel Management -Emphasize the 1/3 rule (1/3 to go. 1/3 to return and 1/3 as reserve. Take appropriate precautions when fueling, take portable tanks off the vessel before fueling, close all hatches, extinguish smoking materials, turn off engines, all electrical equipment, radios, etc.; keep the nozzle in contact with the tank and wipe up any spilled fuel. -Float plan - Explain what it is and suggest leaving a copy with a friend, relative or local marina.

-Insurance considerations-Some states require proof of insurance before registering a vessel. The boater might get a discount if he/she can prove has taken a boating safety class or passed the vessel safety check.
-Boating Check list - the back of the

VSC form can provide a good checklist to review prior to departure.

-Boating Safety Classes - Offer advice of any upcoming classes offered by local flotillas through the District. -Weather and Sea Conditions -Boaters should check local weather forecast before leaving the dock.

- d. Be loosely secured to the air intake to allow sufficient air to the carburetor.


### 2-A PWC Operational Facility;

# ♡<u>Bet You didn't Know…</u>



The goal for D11NR for 2010 is **10,000** VSC's. We are **20%** of our goal for the year and **129%** of 2009 production! The data source is AUXINFO. PLEASE be certain that all stats are reported MONTHLY using the CURRENT Form 7038 to your FSO-IS so you and your unit(s) will receive proper credit.

# National and District News

## District News

-A special request from the Director's office; PLEASE have the qualifying members 7038 with the 5 VSC's entered into AUXDATA by the FSO/SO-IS <u>PRIOR</u> to submission of the MT-2 to the Director's office.

-I'm pleased to announce the new tri-fold 2-sided VSC brochure introduced at D/Train that may be used for VSC stations, Program Visitor racks, and other PA events. You will find the brochure listed on your D11NR Vessel Examiner website:

<u>http://rbsafety.dllnuscgaux.info/ve/ve.html</u> under VE FORMS as ML-5 "Boat Smart from the Start" marked "NEW". The brochure is done in Microsoft WORD and is easily modified for your use.

If you go to the "**For Information Contact**" section, you can highlight and remove my name and replace it with yours, and in most cases keep the same size font and centering. You can do the same for the phone number and email address.

Lastly, this is best printed on #67 weight paper, but, you can also use #20 regular or colored copy paper and also print it in black and white to save on color ink. To print, if you simply print one side and then flip it over and re-run the copy having both pages on one sheet. Another option is your local stationary store copy service.

Since we don't have anything from ANSC specifically for the VSC program, I hope you will consider using this new tool to help to promote our important program.

-Since D/Train, I've received a considerable amount of emails requesting the new orange 3" x 4" kayak/canoe lost and found ID stickers being distributed by the Coast Guard. The "stickers" are in a very limited supply **and have limited distribution thru the Auxiliary**, and thru the CG PA dept. to local CG stations. However, with little effort, I found an option that will work in their place. AVERY makes a 3"x 4" waterproof blank white polyester label # 5524. The labels come in a box of 50 sheets with 6 labels per sheet-300 total. They retail for \$49.99 at stationary stores-about \$.16 per label. They stick firmly and feature durable construction that allows them to repel water and moisture. They also resist scuffs, tears and smudges so they remain easy to read. As with the orange sticker, using a black Sharpie, the label could be made while performing the VSC on a SUB.

As a reminder, a VSC in addition to verifying equipment is a one-on-one education with the boater. This is especially true when examining a SUB. So, if you don't provide the label, along with other recommendations on the 7012A form, you should certainly bring it to the kayaker's attention. -Distribution has **ended** for the recently announced Paddle Smart ID decals. If your request was received, you should receive the decals with in 5-7 days. If you missed out, the decals were distributed to examiners on a 1<sup>st</sup> come 1<sup>st</sup> served basis until the supply is exhausted. Per instructions provided to me, these are only to be distributed when performing a VSC on a kayak, canoe or another small vessel (<u>Sport U</u>tility <u>B</u>oat). Because of the limited quantity, please do not distribute at boat shows or other PA events. In addition, please use in conjunction with the new 7012A. If you do not have the form, you can find it on your D11NR Vessel Examiner website: <a href="http://rbsafety.d11nuscgaux.finfo/ve/ve.html">http://rbsafety.d11nuscgaux.finfo/ve/ve.html</a>. In addition, this is a great opportunity to promote our new Paddlesports America kayaking and canoe course. -When performing a VSC on a SUB (kayak or canoe) with the new 7012A, please give the boater the 7012A form and record your information on a 7038 separate from normal VSC activity. At the end of the end, I'll need to know the total number of VSC's you've performed with the new form. This information along with any comments or

Now is the time to contact the managers of these establishments and secure a spot during NSBW. Some of these stores may allow us to use a part of their parking lot to perform VSCs.
