Activities planned for the next 30 days:



From National: The throwable type IV being required for OPERATIONAL PWC's was brought up to the surface STAN Team on two separate occasions over the last year. Both times it was agreed that the type IV SHOULD NOT be required equipment but that info never made it to the field.

The two changes to the Required Facility Equipment listed in Appendix C of the PWC Operator Qual Guide and listed again in task PWC-03-05-AUX (4.g and 4.r) are- 1. One throwable PFD is no longer required.

2. Spare spark plugs are only required for 2 stroke engines. They are no longer required for 4 stroke engines.

These changes are effective immediately.

A question recently surfaced about: *As vessel examiners are we able to participate in the Zebra/Quagga mussel inspection program?* The answer is...it depends. If you are simply educating the public on the Quagga and Zebra issues while acting as an Auxiliarist and doing a vessel safety check, no problem. Any type of "inspection" that would support a law enforcement type of activity is out of the question. If an Auxiliarist is in uniform (or Polo Shirt) and wants to be trained to perform some kind of "official inspection" on a citizen's boat, that would **not** be authorized. *In addition, PASS or FAIL, the mussel inspection program is NOT part of the Vessel Safety Check. The VSC is a check of specific equipment that is required by federal, state and possibly local law.* This opinion is also shared by Pete Urgola DC-V. If there are any questions regarding the policy, please don't hesitate to contact me.
